Louis Dreyfus Company and Temasek Lifesciences Accelerator to collaborate on agri-food innovation

Singapore, 20 November 2019 – Louis Dreyfus Company (LDC) and Temasek Lifesciences Accelerator (TLA) jointly announced today the signing of a Memorandum of Understanding (MoU) that would see both companies cooperate to advance agri-food innovation in the region.
